1. This bi-annual report summarizes the progress made in programming GEF-4 resources as of June 30, 2010. It provides a cumulative summary of GEF-4¹ utilizations against the programming targets that were established by the Council during the reallocation of remaining GEF-4 resources approved in June 2009 (*Reallocation of Remaining GEF-4 Resources - GEF/C.35/12*). In addition, it details project approvals and endorsements as well as project cancellations during the six-month period from January 1 to June 30, 2010.

³ In July 2007, the corporate budget for the Implementing Agencies was abolished, accompanied by an increase of the agency fee from 9% to 10%, resulting to a decrease in the GEF-4 corporate budget envelope from \$120 million to \$93 million.

2. At the closure of GEF-4 replenishment period, total GEF grants and associated Agency fees approved by Council or the CEO amounted to \$2.97 billion, representing 90% of programmed resources⁴ including the corporate budget. The distribution of the approved amounts as compared to the corresponding programming targets is shown in Table 1 by focal areas, corporate programs⁵ and corporate budget.

APPROVAL OF GRANTS AND AGENCY FEES FOR THE PERIOD FROM JANUARY 1 TO JUNE 30, 2010

3. During the six-month period ending June 30, 2010, the GEF approved a total of \$390.39 million for financing projects, consisting of \$354.91 million in project grants, and \$35.49 million in associated fees to Agencies for project cycle management services. Co-financing associated with total approval during this period was \$2.014 billion (each GEF grant dollar was thus matched by \$5 dollars in co-financing). Table 2 provides a summary illustration of the distribution according to project types.

4. Between January 1, 2010 and June 30, 2010, the CEO endorsed a total of 68 projects accounting for \$344.84 million in GEF grants and \$27.55 million in associated Agency fees, as detailed in Annex D.

5. During the six-month ending June 30, 2010, the GEF has cancelled 8 projects of total value of \$47.20 million in GEF grants and \$6.11 million in associated Agency fees as detailed in Annex E.
